

Cooper Landing Rifle and Sportsman's Club

1. The gate must be locked upon entering and exiting the range. The only exception is when the gate is opened for scheduled events, and the lock is tagged indicating an open range for the event.
2. All posted safety and club rules must be followed.
3. As a member of the Cooper Landing Gun Club the range belongs to you. Common sense and observation of all firearm safety rules will allow continued use of our fine facility. Make safety your first priority when using the range.
4. Eye and ear protection use are required for all shooters and spectators.
5. No one shall handle firearms while others are down range.
6. Firing must be down range only.
7. Unless firing has commenced, actions must remain open, with magazines removed from those that have detachable magazines.
8. Before firing on the range, make sure no one is down range. **MAKE ABSOLUTELY CERTAIN!**
9. Do not loan your range key to anyone. **NO EXCEPTIONS!!** Club members may bring guests to the club. Members are responsible for their guests. Members must have their membership card with them when on the range. **If you are not a member you are trespassing and subject to the law. You will be asked to leave. Range host will be asking for membership cards.**
10. Children must be accompanied by a parent or guardian when on club property. Members are responsible for the safety and actions of all children they bring to the range.
11. Scheduled matches and classes have priority over other range use.
12. Anyone operating a motor vehicle on club property is responsible for that vehicle and must possess a valid driver's license.
13. The rifle range will be closed when the trap range is in use. **NO EXCEPTIONS!!**
14. Be considerate of other shooters on the firing line; keep conversation low and away from firing points. Do not touch other shooters' firearms or equipment without permission. Do not bother shooters when they are at the firing line; distractions cause accidents.
15. Remove your shot up targets, wood, hulls or brass. If you brought it in to shoot take it back out. Don't shoot glass, plastics, etc. on the range or food stuffs such as melons, squash, etc. as it attracts bears and is just trash for someone else to clean up.
16. The possession or use of alcohol or illegal drugs on the range premises is prohibited at all times.
17. Keep off the berms.
18. Report any vandalism or unsafe gun handling to the range officer, or call the club president or secretary.
19. Anyone found in violation of these rules may be subject to expulsion.
20. Range hours are 9:00am to 9:00pm Summer Hours and Daylight hours in winter. Unless lock is tagged or the sign board is up stating the range is closed for that event.
21. **Rifles of 50 calibers or more are prohibited. This does not apply to black powder firearms. Explosives of any kind or explosive targets of any kind such as "Tannerite" are prohibited. Cannons and Mortars of any kind are prohibited.**

Safety Rules:

ALL guns are always loaded.

Never let the muzzle cover anything which you are not willing to destroy.

Keep your finger OFF the trigger until sights are on the target.

Always be sure of your target.
